Purchaser JAVRO 2 Sp. z o.o. invites You to place offers for **Automatic round-corner hardcover casemaking machine**, in connection with investment project subsided by European Union within "Regionalny Program Operacyjny Województwa Śląskiego na lata 2014-2020".

Technical parameters:

- Machine has to be brand new, year of manufacture no earlier than 2015
- Automatic collection of cover from magazine,
- Automatic collection of cardboard from magazine,
- Setup of the machine with touchscreen with setting memory,
- Ability to produce round corner covers,
- Biggest format possible for production not smaller than 670x390 mm,
- Smallest format possible for production not smaller than 160x100 mm,
- Adjusted gap between spine and board no less than 4-15 mm,
- Ability to work with cardboard in thicknesses between 1 4 mm,
- Automatic application of the spine from roll, with automatic cutting as well as ability to work with cardboard spine with thickness up to 4mm,
- Working speed no less than 40 cycles per minute,
- Ability to work on both hotmelt and dispersive glue,
- Automatic regulation of glue viscosity.

# The offer should include cost of transport and assembly of the machine in the factory of the Purchaser.
